- Match play, best 2 out of 3 games
- Rally scoring, played to 25 points, win by 2
- Let serve allowed (serves that hit the net are playable)
- Co-ed rule – minimum of one female on the court at all times
- Overhand serve receive allowed

7pm-8pm: Contender's Bracket Round 3, 8 teams playing on 4 courts. Winner's advance to Contender's Bracket Round 4 and play at 5pm on 8/1. Loser's eliminated from tournament, finish tied for 13th.
